Position on Proposed Nestle Bottling Plant

March 8, 2018

Background:

The Nestle Company is in negotiations with Spring Township Water Authority (STWA) to purchase about 300 gpm (equivalent to 0.66 cfs, 431,490 gpd, or 157.7 million gallons per year) of water to bottle and sell under the Deer Park brand. The water will be extracted from STWA wells in the vicinity of Logan Branch and be piped to a bottling facility located in Spring or Benner townships. Nestle has indicated a desire to begin operating the bottling plant in 2020.

Position:

The Spring Creek Chapter of Trout Unlimited (SCCTU) is concerned about potential negative consequences on the quantity and quality of water in Spring Creek resulting from this project. The chapter plans to monitor the progress of the project and advocate for Spring Creek's trout and other aquatic biota, which otherwise would not have a voice in the process.

Additional thoughts:

STWA will pump the water from wells which are fed from the ground water system in the vicinity of Logan Branch. This same ground water system replenishes Logan Branch and Spring Creek; therefore, effectively the water Nestle will be bottling is coming out of Spring Creek.

The ground water system in the region is recharged primarily by precipitation. In addition, Penn State's spray irrigation system as well as a comparatively small amount of beneficial reuse water from the University Area Joint Authority (UAJA) supplements groundwater recharge. Groundwater reserves are used in this area to supply drinking water and provide water for commercial activity. They can be adversely impacted by drought, contaminated storm runoff, and other pollution. Further, the region is growing, placing ever increasing stresses on the system.

Unfortunately, there isn't a regional water budget, which could be used to assess the impact of such a significant consumptive use as the proposed Nestle withdrawal. SCCTU would like to work with regional partners to help develop an integrated water management plan that considers the health of Spring Creek watershed for aquatic life in equal weight with needs of regional population growth and economic development.

SCCTU will advocate for a transparent and deliberate project approval process, which seeks community engagement and takes the time necessary to weigh alternatives, consider science, and arrive at the best solution for Spring Creek.

Finally, SCCTU plans to participate in the regulatory approval process and advocate on behalf of Spring Creek's aquatic resources.
