Jun 3, 2017 — Quick updates from Katherine Watt (I'm back as admin for the Change.org updates).

Organizing has been moving quickly in the last week or so, apologies for the delayed update to Change.org petition signers.

1. Plaintiffs have decided to appeal the May 17, 2017 Commonwealth Court decision - which reversed the July 18, 2016 Common Pleas decision which vacated the November 16, 2015 Ferguson Township supervisors' approval of the Toll Brothers development - to the PA Supreme Court.

2. There's another online petition, started by Lori Bedell of Friends of Slab Cabin Run, this time demanding that Penn State back out of the sales contract with Toll Brothers.

3. To reinforce the message to Penn State, Nittany Valley Water Coalition launched a tent occupation of the parcel this morning (Saturday, June 3), near the intersection of Whitehall Road and Blue Course Drive.
